## ORDER

- S.O. ----- (E). In exercise of the powers conferred by section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government is of the opinion that it is necessary so to do in the public interest and after consulting the Bureau of Indian Standards, hereby makes the following order, namely: -
- Short title and commencement.- (1) This Order may be called the Bearing Components and Accessories (Quality Control) Order, 2025.
- (2) It shall come into force on the date of its publication in the Official Gazette.
- 2. Compulsory use of Standard Mark. Goods or articles specified in column (2) of the Table shall conform to the corresponding entry specified in column (3) of the Table and shall bear the Standard Mark under a licence from the Bureau as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018 from the date specified in the corresponding entry under column (5) of the Table:

Provided that the micro enterprises and small enterprise, as defined under the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006) shall conform to such Indian Standards from the date specified in the corresponding entry under columns (6) and (7) of the Table respectively:

Provided further that nothing in this Order shall apply to the following, namely:-

- (a) goods or articles manufactured domestically for export:
- (b) goods or articles imported as a part of any finished good or sub-assembly or component;
- (c) goods or articles imported by a manufacturer for manufacturing equipment or product or sub-assemblies or component in India for exports subject to the condition that the manufacturer furnishes a self-declaration in this regard in its letter-head signed by its authorized signatory to the Central Government mentioning the invoice number and other relevant details of the import consignment and an undertaking that the goods or articles so imported shall not be put to any other use or sold in the domestic market and the manufacturer shall maintain the record of such goods and articles imported and its product for verification or audit by the Government authorities concerned;
- (d) two hundred numbers of goods or articles imported for the purpose of research and development by manufacturers of bearing components and accessories per year with the condition that such imported goods and articles shall not be sold commercially and can be disposed of as a scrap and the manufacturer shall

maintain a year-wise record of such goods or articles and furnish to the Central Government:
