- S.O. ----- (E).- In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government is of the opinion that it is necessary so to do in the public interest and after consulting the Bureau, hereby makes the following order, namely: -
- Short title and commencement (1) This Order may be called the Chain Pulley Block, Ratchet Lever Hoist and Universal Gearless Pulling and Lifting Machine (Quality Control) Order, 2025.
- (2) It shall come into force on the date of its publication in the Official Gazette.
- 2. Compulsory use of Standard Mark (1) Goods or articles specified in column (2) of the Table shall conform to the corresponding Indian Standard specified in column (3) of that Table after the time limit specified in column (5) thereof.
- (2) The good or articles specified in column (2) of the Table manufactured by micro enterprises and small enterprises as defined under the Mirco, Small and Medium Enterprises Development Act, 2006 (27 of 2006) shall conform to the corresponding Indian Standards specified in column (3) of that Table after the time limit specified in columns (6) and (7), respectively, thereof.
- (3) The provisions of this order shall not apply to goods or articles imported to a maximum of hundred numbers per year by a manufacturer:

Provided that the goods or articles imported by the manufacturer shall not be sold commercially and be disposed of as scrap and the manufacturer shall maintain year wise record of those goods or articles and furnish the same to authorities concerned, as per the directions issued from time to time.

- (4) Nothing in this order shall apply to goods or articles manufactured domestically for export.
- Certification and enforcement authority The Bureau shall be the certifying and enforcing authority for the goods or articles specified in the Table.
- **4. Penalty for contravention -** Any person who contravenes the provisions of this Order shall be punishable under the provisions of the Bureau of Indian Standards Act, 2016.
