- **S.O. 4606 (E).**—In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian Standards is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following order to amend the Polyester Industrial Yarn (Quality Control) Order, 2022, namely:—
- **1. Short title and commencement.** (1) This order may be called the Polyester Industrial Yarn (Quality Control) Amendment Order, 2022.
 - (2) It shall come into force on the date of its publication in the official Gazette.
- 2. In the Polyester Industrial Yarn (Quality Control) Order, 2022 (hereinafter referred to as the said Order), in paragraph 1, for sub-paragraph (2), the following sub-paragraph shall be substituted, namely:—
 - "(2) It shall come into force on the 3rd day of April, 2023."
- 3. In the said Order, after paragraph 4, for the TABLE, the following TABLE shall be substituted, namely:—
