विषय: दिनांक 01.05.2026 से वित्त अधिनियम (2026 की संख्या 3) की चौथी अनुसूची द्वारा यथा संशोधित सीमा शुल्क प्रशुल्क अधिनियम, 1975 की पहली अनुसूची में परिवर्तन के परिणामस्वरूप आरओडीटीईपी अनुसूची का संरेखण।

का.आ. 2254(अ).—समय-समय पर यथा संशोधित विदेश व्यापार नीति 2023 के पैरा 1.02 के साथ पठित विदेश व्यापार (विकास एवं विनिमयन) अधिनियम, 1992 की धारा 5 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, केन्द्र सरकार एतद्वारा सीमा शुल्क प्रशुल्क अधिनियम, 1975 के तहत किए गए संशोधनों के साथ आइओडीटीईपी अनुसूची को संरेखित करने के लिए दिनांक 01.05.2026 से परिशिष्ट 4द और परिशिष्ट 4दड में निम्नलिखित संशोधन करती है:

- 8 अंक स्तर पर 142 प्रशुल्क लाइनों को आरओडीटीईपी अनुसूची के परिशिष्ट 4द और परिशिष्ट 4दड में जोड़ा गया है।
- 8 अंक स्तर पर 50 प्रशुल्क लाइनों को आरओडीटीईपी अनुसूची के परिशिष्ट 4द और परिशिष्ट 4 दड से हटा दिया गया है।

- iii. 8 अंक स्तर पर 02 प्रशुल्क लाइनों के विवरण को आरओडीटीईपी अनुसूची के परिशिष्ट 4द और परिशिष्ट 4दड में परिवर्तित किया गया है।
