ORDER

S.O.----(E).- In exercise of the powers conferred by sub-section (1) and (2) of section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely:-

- 1. Short title and commencement. -(1) This Order may be called the Furniture (Quality Control) Order, 2022.
 - (2) It shall come into force with effect from date.....
- Compulsory use of Standard Mark. Goods or articles specified in the column (2) of the Table shall conform to the corresponding Indian Standard specified in column (3) of the said Table and shall bear the Standard Mark under a licence from the Bureau as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.
 - (2) Provided that nothing in this Order shall apply to goods or articles meant for export.
 - (3) Provided that nothing in this Order shall apply to goods and articles manufactured by any Micro enterprise as defined in Ministry of Micro, Small and Medium Enterprises Notification S.O. 1702 (E). dated 1st June, 2020.
 - (4) Provided further that nothing in this Order shall apply to goods or articles manufactured and sold by Artisans registered with Office of the Development Commissioner (Handicrafts), under Ministry of Textiles, Government of India.
 - (5) Provided further that nothing in this Order shall apply to goods or articles manufactured and sold by Registered proprietor and Authorised user of a product registered as Geographical Indication by the Registrar of Geographical Indications, Office of Controller General of Patents, Designs and Trademarks (CGPDTM), under Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India.
- Certification and Enforcement Authority. The Bureau shall be the certifying and
 enforcing authority for the goods or articles specified in the column (2) of the said
 Table.

4. **Penalty for Contravention.** - Any person who contravenes the provisions of this Order shall be punishable under the provisions of the Bureau of Indian Standards Act, 2016.
